Impartiality and Confidentiality Declaration

The purpose of this section is to ensure that the objectivity of ASTC-TI management system certification and inspection activities. Based on a management system that complies with the requirements of ISO/IEC 17065, ISO/IEC 17020 and GAC, SASO and IAS guidelines, ASTC-TI operates in a standardized manner to ensure the objectivity and impartiality of certification and inspection activities from various aspects, including institutional policy, certification/inspection process, decision and organizational structure, and personnel control. The impartiality policy formulated by ASTC-TI also shows that ASTC-TI understands the importance of impartiality in the implementation of management system activities and manages conflicts of interest.

ASTC-TI ensures and promises:

- Establish a complete impartiality management system to continuously identify, analyze, evaluate, handle and monitor risks related to conflicts of interest and certification activities. When there is a threat to impartiality, corresponding risk control measures will be formulated to eliminate or minimize such threats to an acceptable level, and ensure the impartiality of certification activities.
 - 建立完整的公正性管理体系,持续识别、分析、评价、处理和监控与利益冲突和认证 活动相关的风险。当存在对公正性的威胁时,制定相应的风险控制措施,将这种威胁 消除或降低到可接受的程度,确保认证活动的公正性。
- ASTC-TI shall not state or imply that certification would be easier or less expensive if any specified person, or consultancy organization were used.
 ASTC-TI 不得宣称或暗示使用任何指定人员或咨询机构将使认证更为便捷或廉价。
- All personnel that are involved in the certification and inspection activities: 所有参与认证和检验活动的人员:
 - a. Shall act objectively and be free from any undue commercial, financial or other pressures that could compromise impartiality.
 - b. 应客观行事,不受任何可能损害公正性的不当商业、财务或其他压力的影响
 - c. Disclose any situation known to them that may present them or ASTC-TI with a conflicts of interest.
 - 披露其了解的任何可能导致本人或 ASTC-TI 发生利益冲突的情况。

- d. At no time any of them give or receive any gift/ benefit or accept an invitation that would in any way cause ASTC-TI embarrassment, or do anything that could alter their performance of his or her duties or influence decisions.
 - 任何人任何时候都不应给予或接受任何礼物/利益,或接受任何可能导致 ASTC-TI 尴尬的激请,或做任何可能改变其履行职责或影响决策的事情。
- e. Not to participate in product design, development, production, supply, installation, use or maintenance activities related to certification or inspection projects or similar competitive projects.

不得参与和认证或检验项目或者类似的竞争性项目有关系的产品设计、研制、生产、供应、安装、使用或者维护活动。

- f. Not disclose confidential, trade secret or proprietary information obtained during certification and inspection activities.
 - 不得泄露在认证和检验活动中获得的机密、商业秘密或专有信息。
- Adheres to the principle of impartiality, independence and non-discrimination, and is open to all qualified applicants without any financial and other restrictions. ASTC-TI can decline to accept an application or maintain a contract for from a client when fundamental or demonstrated reasons exist.

 All personnel understand the policy of protecting impartiality and are implemented at all levels of the organization, so that the behavior of its personnel is consistent with impartiality.

 Establish an impartiality committee composed of representatives of multiple stakeholders to balances the interests of all parties, and neither party is in a dominant position. The committee regularly supervises the implementation of ASTC-TI impartiality policy and impartiality risk control measures to maintain the impartiality of certification activities.
